3. **COACHES PASSES**
Four per Club
4. **WITHDRAWALS**

5. **SEEDING**
All events are **HEAT DECLARED WINNER**. Heats will be seeded according to the submitted times. Swimmers with no entry time will be placed in the slowest heats.
6. **ELECTRONIC TIMING**
Times and places on the electronic scoreboard are for information only and are not necessarily the official result.

Awards will be presented to the top 3 in each age group:-
8 years, 9 years, 10 years, 11 years and 12 years
